C) Minimum per-pupil Funding Level (MFL)

As part of the levelling-up of schools per-pupil funding the Government have specified minimum levels of funding per pupil that all schools must receive through the formula allocation. If, for any reason, a schools' formula does not provide sufficient to meet the MFL then their budgets are topped up to guarantee they can achieve the minimum funding requirement.

The MFL has been introduced as part of the National Funding Formula (NFF) as follows:

In order to ensure the addition of the Teachers Pay and Pensions grants into the per-pupil funding formula does not disadvantage any school that would require the MFL protection, the equivalent amounts have been added to the MFL to be used in all formula budget determinations by Local Authorities and is included in the validations of the Authority Pro-Forma Tool (APT) to be submitted for 2021/22.

The MFL provides increased funding totalling £1,286,6060 for 21 schools/academies in 2021/22

D) Minimum Funding Guarantee (MFG)

MFG provides an additional protection that is designed to mitigate excessive turbulence in per-pupil funding from one year to the next. Schools' Forum have recommended the MFG is set at 2.00% for 2021/22, thus ensuring no schools/academies will see a reduction in their per-pupil funding by more than 2% per pupil when compared to 2020/21. This protection has supported 27 schools/academies in 2021/22 with funding totalling £320,905

E) Schools Block Transfer

Regulations allow for Local Authorities, with the approval of their Schools' Forum, to transfer up to 0.5% (half a percent) from the Schools Block to support pressures in other DSG block areas. Any request to transfer an amount greater than 0.5% is subject to a separate 'dis-application' submission that requires the approval of the Secretary of State.

Predominantly most proposals to move funding arise a result of pressures being faced within the High Needs Block.

The regulations have been updated for 2021/22 to ensure any proportion of funding in respect to the transfer of Teachers Pay and Pensions grant into the Schools Block is not considered in any block movements calculations.

Based on the 2021/22 Schools Block allocation, the calculation of the amount that Bury could transfer from the Schools Block is therefore:

F) Central Schools Services Block (CSSB)

Introduced in 2018/19 to be used for former Education Services Grant (ESG) functions such as Education Welfare, Ongoing Responsibilities such as Admissions and Historical Commitments which for Bury is the Safeguarding in Schools Officer.

The CSSB DSG allocation has been derived from the former ESG funding allocation plus budgets previously identified under the Central Spend area of the DSG. The CSSB continues to provide funding direct to the Local Authority to enable it to carry out central functions on behalf of all Maintained Schools and Academies.

The table below indicates the breakdown of areas covered under this block. For 2021/22 the DfE have increased the allocation for inflation and Teachers Pay and Pension Grants in respect to any centrally employed teachers.

G) Early Years

All Early Years settings, whether Maintained Nursery School/Classes, Private Voluntary and Independent (PVI) or Childminders delivering early education entitlements are funded according to the Early Years National Funding Formula (EYFF).

The formula is primarily driven by Hourly rates for 2, 3 and 4 year olds and the mandatory Deprivation factor. Additional funding is provided to individual settings based on the eligibility of their pupils for Early Years Pupil Premium Grant (EYPPG), Disability Access Fund (DAF) and the Maintained Nursery School (MNS) supplement for Hoyle only.

The allocation of the Early Years Block of the DSG is subject to a statutory 'Pass-Through' of 95% which means no more than 5% of the funding may be retained by the Local Authority. The retained element of funding is held in continency in order to enable in-year adjustments to funding allocations for changes in headcounts and hours of participation, provides the Early Years Inclusion Fund to support SEND requirements in all settings, and contributes to the central functions associated with ensuring the EYNFF is administered effectively, which includes the duties required in order to operate the funding mechanism and allocations, sufficiency, quality assurance and advisory services, together with ensuring all eligibility checking is able to be undertaken centrally for all early years pupils.

For 2021/22 the hourly rates determinations have been increased nationally according to the Treasury assumptions on inflation. The notified increases are 8 pence per-hour for 2 year olds and 6 pence per-hour for 3 and 4 year olds. To ensure the full increase to hourly rates provided by the DfE are passed through to settings the LA will not increase any retained element of funding.

The Hourly Rates are subject to approval by Schools' Forum and will be applied to the EYNFF with effect from 1 April 2021. The Hourly Rates are as follows:

Funded Headcounts

Due to the current pandemic situation, early years settings have been protected by ensuring funded headcounts have been based on pre-Covid census data. For 2021/22 the DfE guidance is to revert back to actual headcounts as at January 2021 and an alternative protected funding model is to be introduced. The details are awaited and all early years settings will be informed as soon as practically possible of the impact of the new calculation when known.

H) High Needs

The high needs funding system supports provision for children and young people with special educational needs and disabilities (SEND) from their early years to age 25, enabling both local authorities and institutions to meet their statutory duties under the Children and Families Act 2014. High needs funding is also intended to support good quality AP for pre-16 pupils who, because of exclusion, illness, or other reasons, cannot receive their education in mainstream or special schools. The high needs funding block provides local authorities with resources for place funding and top-up funding for institutions, and funding for high needs services delivered directly by the local authority.

For 2021/22 the High Needs Block includes the Teachers Pay and Pensions Grant allocation which is required to be added to the Special School and Pupil Referral Unit funding, with mechanisms in place to ensure this increase is not in any way offset through reductions in top-up funding. Based on the level of grant the DfE have determined an additional £660 per place must be added per place.

Special Schools

A banded funded model is in place for Bury's Special schools which is linked to moderated assessments of SEND in accordance with the graduated approach and criteria included in the SEND Code of Practice. The banded model and values for 2021/22 are outlined as follows:

I) PUPIL PREMIUM GRANT (PPG)

The Government have announced that the PPG unit values in respect to Deprivation, Looked After Children (LAC), former LAC (Post-LAC) and Service Children will remain unchanged for 2021/22. The only change to note is that From April 2021, Pupil Premium allocations will be calculated based on the number of eligible pupils recorded by schools in their census in October 2020, previously it has been based on the January census each year.
