

Anti-Social Behaviour Policy - A Summary

This document provides a summary of Bury Council's approach and the actions that will be taken when a report of Anti-Social Behaviour (ASB) is received. This summary outlines different types of ASB, how it can be reported, who it should be reported to and the likely next steps.

Bury Council recognises that all residents within our borough have the right to live without experiencing anti-social behaviour.

Serious ASB involving criminal conduct should be reported to Greater Manchester Police by telephoning 101, or online at https://www.gmp.police.uk/contact/af/contact-us/

In an emergency call where there is threat to life or property always call 999.

Below is an easy-to-read guide regarding the ASB process that Bury Council adhere to. This is a simplified version and it is important to note that progressing through the stages is reliant on receiving strong evidence throughout each stage. Types of ASB

Neighbour disputes	- Privately rented or owned property - Report to Bury Council
Noise and environmental nuisance	- Social Housing Accommodation - Six Town Housing or other social housing provider. To ensure your complaint is handled by the correct housing provider please check who manages the property before submitting.
Hate crime/Hate incidents	-Report to Greater Manchester Police (GMP) in the first instance
Use of violence or threatening behaviour	-Follow up:
Repeated abusive language or behaviour	Privately rented or owned - Bury Council
Harassment	Social Housing Accommodation - Six Town Housing or other social bousing provider.
Damage to property	housing provider
Domestic abuse or violence	

Criminal behaviour	
Misuse of open spaces, including begging/off-road use of vehicles

Reports of ASB should include as much detail as possible and can be made in any of the following ways depending on the location and severity of the ASB:

Reports of ASB can be made by a third party, for example by a Local Councillor, Member of Parliament, or social worker. If a report is made via a third party, we will seek the consent of the complainant to communicate and share information with the third party.

Reports of ASB are **not** accepted by social media e.g. Twitter, Facebook.

Investigating ASB

Levels of Evidence

Within this Council policy, most ASB investigations take place within a civil law framework which means a civil standard of proof is applicable. The Investigating Officer needs only to be able to demonstrate that the incident(s) is more likely, than not to have happened.

When civil legal action has been taken and a Court Order has been disobeyed i.e., breach of an Injunction order, Closure Order, or prosecution for breach of a Community Protection Notice; the criminal standard of proof applies. This means that the Investigating Officer will need to demonstrate that the incident(s) happened are "beyond reasonable doubt".

Insufficient Evidence

During an investigation there may be several reasons why an Investigating Officer cannot take action. These may include:

• Establishing that the incident did not happen

- Not having enough evidence to prove the matter to the relevant standard of proof
- Finding the issues reported to be not what Bury Council consider as antisocial
- Not being able to investigate fully due to non-cooperation of the complainant / witness
- The ASB has stopped and the likelihood of further ASB is low


In each case, the Investigating Officer will inform the complainant at the earliest opportunity if they determine that they cannot take further action.
