The Reading Rooms are well supplied with carefully selected Newspapers and Periodicals, and a number of Directories. The Lending, Reference, and Juvenile Libraries contain 38,876 volumes of the most representative Literature in all branches, and the circulation for the year ending October 8th, 1934, totalled 351,249 issues. Libraries are established in 20 Elementary Schools in the Borough, and a Branch Delivery Station, of some 450 volumes, is established at the Hollins Post Office, Unsworth.

The Public Libraries Act was adopted by a vote of the Council on June 3rd, 1897, and the provision for Libraries and Reading Rooms consists of Reference, Lending, Choir Music, and Juvenile Libraries, Men's and Women's Reading Rooms, Borrower's Hall, Book Stores, and Lavatories.

The stock of books available for use numbers 38,876 volumes, and the circulation for the year ending October 8th, 1934, totalled 351,249 issues.

Important gifts and bequests have been made to the Library and Reading Rooms by the late Mrs. Clifford Davies, the late Mrs. John Grundy, the late O. O. Wrigley, Esq., the late Alex Taylor, Esq., and the late Alderman S. Kay.

Books may be borrowed free by any person resident, rated, or employed within the Borough, by filling up the required forms, which may be obtained on application at the Library.

The method of lending books was changed from the Indicator to the Safeguarded Open Access System on June 15th, 1909.

A Branch Delivery Station was established at Unsworth, in the Hollins Post Office, on April 5th, 1933.

Twenty elementary schools in the borough are supplied with books from the Library.

MUSEUM.

Opened by the late Alderman J. K. Butcher, J.P., on October 19th, 1907. Daily Hours of Opening as Art Gallery.

Curator-Mr. John H. Shaw.

The Museum was opened on October 19th, 1907, by the late Alderman J. K. Butcher, J.P., Chairman of the Committee. It contains Natural History, Art, Historical, and General Collections, lent or presented by townsmen and Government Departments. The room in which they are housed is a basement

floor, approached by a staircase from the Art Gallery Entrance Hall, adapted admirably for its purpose by the provision of patent lighting and flooring.

The building was erected at a cost of about £37,000.

THE CEMETERY.

Registrar and Superintendent-Mr. GEO. MAUNDER.

The Cemetery is open to the public from 7 a.m. to 9 p.m., from May 1st to July 31st (Sundays, 8 a.m. to 9 p.m.); and from 8 a.m. to sunset, from August 1st to April 30th.

The Registrar's Office at the Cemetery is open daily (except Sundays) from 9 a.m. to 3 p.m., for the sale of graves, notice of interments, etc., and till 12 o'clock on Saturday.

The Registrar will deliver to the purchaser of a Grave, a "Grant of Exclusive Right of Burial," which must be produced to the Registrar, at the Cemetery, before any grave can be opened.

Thirty six hours' notice, at least, to be given to the Registrar of intention to inter, but if the interment is intended to be on a Monday, the notice must be given not later than 10 o'clock the previous Saturday, if the interment is intended to be on a Tuesday, the notice must be given not later than 10 o'clock on the previous Monday morning. When a Vault or Bricked Grave is to be made three clear days' notice is to be given. A Certificate from the Registrar of Births and Deaths is required before the interment of a still-born, and the Registrar's certificate or Coroner's order for burial in all other cases.

The hours of interment are, on Week-days only, all the year through: Church, 3 p.m.; Nonconformist, 2 p.m.; Catholic, 4 p.m. (Saturdays excepted).

Saturday.—Nonconformist Ground, at 12 noon; Consecrated, at 1 p.m.; Roman Catholic, at 2 p.m. No Interments allowed at a later hour.

No Vault or Grave in which the exclusive right of Interment has been purchased, shall be opened without the Owner's Consent, unless by some lawful authority.

No person will be allowed to remove or carry away flowers or plants, which have been grown, placed, or planted on any grave space, without first having received permission in writing from the Superintendent.

15. If any alteration be made in the day or hour previously fixed for an interment to take place, notice thereof shall be given to the Registrar not later than 10 a.m. on the day of interment.

- 17. When it is not intended to use the Chapels at the Cemetery for the burial service, notice must be given to the Registrar on the application being made for opening the grave.
- 19. In any case at which the burial is one at which a number of persons may be expected to assemble, the fact must be notified to the Registar at least one clear day before the funeral, so that arrangements may be made accordingly. The Corporation reserve to themselves the right at any time to exclude from the Cemetery all persons other than mourners and persons officially connected with funerals.
- 28. No interment shall take place on Sunday, Good Friday, or Christmas Day. The hours stated for interments are the latest at which the funeral procession should arrive at the respective chapels, and punctuality must be strictly observed, otherwise a fine of ONE SHILLING for every five minutes or fractional part thereof which the funeral may be late, will be imposed.

Alarms of fire can also be sent to the Chief Station by Electric Street Fire Alarms—by breaking the Glass. These Fire Alarms are situated as follows: Rochdale Road, near top of Pimhole Lane; Wrigley Lane, off Rochdale Road; Woolfold, near Swan Hotel; Wellington Street; Victoria Street, near the Gas Works; Bridge Street, opposite Bridge Inn; and Huntley Brook, in Brewers Arms In Wall.

THE JURISDICTION OF THIS COURT EXTENDS OVER THE FOLLOWING TOWNSHIPS:—Ainsworth, Birtle-cum-Bamford, Bury, Heywood, Outwood, Radcliffe, Ramsbottom, Tottington, Unsworth, Walmersley-cum-Shuttle-worth, Whitefield.

All actions where the claim is admitted, and all actions on contract, where the defendants do not appear, will be taken before the Registrar at Ten o'clock on the forenoon of the days on which they are entered for trial.

If a claim exceeds £2, the plaintiff must, on entering the plaint, leave with the Registrar two copies of the particulars of the claim for each defendant. Plaintiffs must give the exact residence and business of the defendant. They must also have all necessary account books, etc., with them in Court on the trial of each case. Fees on summonses and executions must be paid when the same are entered. Hearing fees must be paid before or when each case is called. No money will be paid out the first week in January.

The County Courts have jurisdiction in all personal actions where the debt, damage, or demand does not exceed £100, whether consisting of an original demand of £100, or of a larger amount reduced by a set-off to that amount; and by consent of the parties the Courts have jurisdiction with respect to all actions assigned to the King's Bench Division of the High Court; and a summons against a defendant residing out of the jurisdiction of the Court may be obtained at the office by leave of the Registrar.
