

## **Public Rights Of Way User Evidence Form**

## **Important Note**

- Part III of the Wildlife and Countryside Act 1981 requires the Council to keep a record of public rights of way in Bury ("the Definitive Map"). In addition, the Council has a duty to determine applications to modify the Definitive Map and Statement (DMMO applications).
- This form is for use by anyone who has personal knowledge about public use of (1) any route in Bury for which a public right of way is not recorded, but is claimed to exist, or (2) any public right of way claimed to be recorded incorrectly (either status or position).
- Bury Council will protect your personal data and ensure that it is presented fairly and lawfully. Information will be processed in accordance with the General Data Protection Regulations, The Data Protection Act 2018 and subsequent legislation. The Council will process your information in accordance with the legal obligation under the Wildlife and Countryside Act 1981.
- The Council may be required by law to allow other persons to have access to completed forms and other documents relating to a Definitive Map claim. If you provide personal information, either using this form or any other document relating to a Definitive Map claim, it could become accessible to the public. The information will only be processed for the purpose of determining the Definitive Map claim.
- Each individual who wishes to give evidence should complete their own form.
- The whole form should be completed. Use a separate form for each route if you have information about more than one.
- The Council will take into account all the relevant evidence, including user evidence forms. If the Council makes an order to modify the Definitive Map and the order is subject to objections, the evidence will be examined by an Inspector on behalf of the Secretary of State.
- If you have been provided with this form by someone who is preparing a Definitive Map claim, please return any completed form to them and not the Council.
